The Police Jury of the Parish of Avoyelles, State of Louisiana, met in Regular Session at its regular meeting place, the Police Jury Meeting Room of the Parish Courthouse, on Tuesday, June 12, 2018, at 6:00 p.m. (CST).

The invocation was given by President Charles Jones.

The Police Jury of Avoyelles Parish, was duly convened as the governing authority of said Parish by Hon. Charles Jones, President, who welcomed all present and stated the Police Jury was ready for the first item of business.

The President asked if there were any public comments. The comments from the audience is as follows: None.

On motion by McKinley Keller, seconded by Marsha Wiley, the Avoyelles Parish Police Jury does hereby adopt the minutes of the Regular Meeting held on May 15, 2018, as printed in the "Weekly News", official Journal of the Parish and mailed to all Jurors. On vote, the motion carried.

Delegates:

Honorable Connie Couvillon, Clerk of Court addressed the Jury expressing need for another Archives Building.. There is currently one Archives Building near the Courthouse on Washington Street but storage has become limited. Mrs. Couvillion requested permission to negotiate a sale for a building within walking distance of the Courthouse to serve as a second Archives Building.

On motion by Henry Moreau, seconded by Mark Borrel, the Avoyelles Parish Police Jury does hereby authorize Honorable Connive Couvillion to negotiate a sale for an Archives Building, at no cost to the Parish. The Parish will provide insurance at their expense. Further, the Jury authorizes the President to sign all documents to effectuate the purchase. On vote, the motion carried.

Mr. Davis Evans voiced concern regarding the recent pumping of water from Spring Bayou. Mr. Evans advised the Jury he began an online Petition and has over 700 signatures requesting the Parish to stop locals from pumping water. The Jurors advised Mr. Evans of a recent meeting with Department of Wildlife and Fisheries to establish water management. A follow-up meeting was requested in July.
