Call to Order

Dr. Henry Moreau called the meeting to order at 7:40 AM and led the group in the Pledge of Allegiance.

Repair of Pete Laborde Rd

Dr. Moreau briefed the attendees on the condition Pete Laborde Rd. He considers the 4.6 mile road running from Hwy 451 in Hamburg to Hwy 451 in Bordelonville, currently impassable. Dr. Moreau had discussions with Carl Leonard, who contracts motor graders. Mr. Leonard has one available in the very near future that can be utilized for the repairs. The Greater APPJ has offered to RD2, through discussions with Dr. Moreau, that APPJ will provide all replacement culverts for Pete Laborde Rd, provided that RD2 completes the necessary repairs with RD2 funds. Mr. Leonard advised that he would charge \$100/hr for 10 hour days for the motor grader and operator. He estimated that he could complete the repairs within 4 or 5 days, for a total charge of \$4,000 to \$5,000. Drainage on Pete Laborde Rd is poor and ditches will have to be cleaned, and in some cases rerouted. Kevin Bordelon suggested that the APPJ dozer be utilized to do the heavy repairs on the road and heavy ditch work, before getting Mr. Leonard's motor grader to finish the repairs. Kevin said the dozer could be made available by Monday, August 14, 2017.

Motion to proceed with repairs on Pete Laborde Road

Duane Lacour moved that the APPJ dozer be utilized in the near term to rough-in the repairs to Pete Laborde Rd and to the drainage network, and that RD2 Commission hire Mr. Leonard's motor grader to finish the repairs, up to a total of \$5,000. Reverend Leslie Draper seconded the motion. The motion passed.

Approval of minutes of June 27, 2017 and July 18, 2017 RD2 Commission meetings

Tim Bordelon had previously distributed draft meeting minutes from the APPJ RD2 Commission meetings held on June 27, 2017 and July 18, 2017 by email. Dr. Moreau called for any discussion on those draft minutes; there was none. Tim Bordelon moved that both sets of minutes be accepted by the Commission as written. Rev. Leslie Draper seconded the motion. The motion passed and the minutes were accepted into record.

Next Meeting

Regular RD2 meetings are held on the third Tuesday of each month. The next meeting is tentatively scheduled for Tuesday, September 19, 2017 at 5:30 PM.

Motion to adjourn

Tim Bordelon made a motion to adjourn. Duane Lacour seconded the motion. Vote was unanimous and the meeting adjourned at 8:25 AM on August 8, 2017.
