The Police Jury of the Parish of Avoyelles, State of Louisiana, met in Special Session at the LSU Ag Center, Mansura, La, at 4:00 p.m. (CST).

The Police Jury of Avoyelles Parish, was duly convened as the governing authority of said Parish by Hon. Charles Jones, President, who welcomed all present and stated the Police Jury was ready for the first item of business.

On motion by Marsha Wiley, seconded by Mark Borrel, the Avoyelles Parish Police Jury does hereby approve to amend a previously adopted motion, the newly adopted motion is as follows: Kerotest will be granted tax relief at 80% for five (5) years, with provisions to renew the exemption at 80% for three (3) years. On vote, the motion carried.

On motion by Henry Moreau, seconded by John Earles, the Avoyelles Parish Police Jury does hereby authorize the President to act as an agent for the donation of material from DOTD, Project No. H.012922. On vote, the motion carried.

On motion by seconded by Mark Borrel, seconded by Trent Clark, the Avoyelles Parish Police Jury does hereby grant authority to the Secretary-Treasurer to pay all bills and to waive a reading of the whole. Motion carried.
