

**Avoyelles Parish Police Jury Regular Meeting**  
**Tuesday, January 9, 2018**

The Avoyelles Parish Police Jury met in Regular Session on Tuesday, January 9, 2018 at 6:00 PM in the Police Jury Meeting Room of the Parish Courthouse, Marksville, Louisiana with the following members present:

The meeting was called to order by District Attorney Charles Riddle.

The meeting opened with the Pledge of Allegiance to the Flag of the United States of America led by Kirby Roy followed by an opening prayer led by Charles Jones.

District Attorney Riddle opened the floor for nomination for Vice-President.
