In 2018 Phase I of Capital Outlay was completed. The two roads that were partially resurfaced were Zion Road, District No. 4 and Scroggs Road, District No.1. The Jury plans continue with Phase II which includes resurfacing Clemile Dauzat Road; Bill Belt Road; Barron Lane; Catfish Kitchen; and, South Live Oak Street.

She is hopeful the new location for the branch in Effie will be completed later this year. Once the Effie and Mansura locations are underway, she will begin working on plans to renovate the Bunkie Library.

certified copy thereof shall be forwarded to the Secretary of State, Baton Rouge, Louisiana, who shall record the same in his office; another certified copy thereof shall be forwarded to the Clerk of Court and Ex-Officio Recorder of Moorages in and for the Parish of Avoyelles, who shall record the same in Mortgage Records of said Parish; and another copy of thereof shall be retained in the archives of this

Governing Authority

SECTION 3. Promulgation The results of said election shall be promulgated by publication in the manner

provided by law
